MINUTES OF THE 55TH MEETING OF BUILDING & WORKS COMMITTEE
HELD ON 07.01.2019

The 55th Building & Works Committee meeting was held on 07.01.2019 at 10.00 AM in the NIT Transit House, New Delhi. The meeting was chaired by Prof. Sivaji Bandyopadhyay, Chairman, B&WC and attended by the following members:

At the outset of the meeting the Chairman welcomed the members of the Committee after that the following agenda items were taken up.

BWC-55/19/01: To confirm the minutes of the last (54th) meeting.

The minutes of the 54th meeting of the B&WC were circulated among all members and no comment was received. The minutes were confirmed and recommended to FC.

BWC-55/19/02: To take note on action taken and progress made on the resolution of the 54th meeting held on 14.11.2018.


The B&WC noted the action taken report.

BWC-55/19/03: To report about the action of CPWD in respect to Internal Road work at NIT Silchar.

The committee discussed the matter in detailed and decided that renovation of Internal road to be cancelled from CPWD due to enormous delay for submission of detailed estimate. Further CPWD is to be asked for refund the amount of Rs. 3,00,000.00, which was paid by the Institute for preparation of Detailed Project Report as demanded by the CPWD.

The committee also decided that Institute may take up the repair works on priority basis which are under the purview of Director.

The decision of the committee may be forwarded to FC & BOG for approval.



BWC-55/19/04: To consider the estimate for the following works.

BWC-55/19/05: To consider proposal for construction of boundary wall at proposed Transit House near Airport, Silchar.

BWC-55/18/06: To consider proposal for special repair to non-residential functional buildings and faculty quarters of the campus.

A proposal was discussed and the B&WC decided to constitute a committee to assess the health condition of these structure & necessity for the repairing. The Chairman B&WC is authorised for constitution of committee. The report of the same will be placed in the next B&WC meeting.

BWC-55/18/07: To consider proposal for levelling of Sports Ground and rain water drainage at NIT Silchar.


The committee is recommended & accepted the proposals in principle. However, the execution should be carried out after getting clearance from the MHRD.

BWC-55/18/08: To consider proposed Construction of physically challenged students lift (6 nos) & toilet facilities at NIT Silchar.

The committee is recommended the proposal for Construction of physically challenged students lift (6 nos) & toilet facilities at an DPAR amount of Rs. 4,57,81,233.00. The Civil Engineering Department of NIT Silchar may be prepared the detailed drawing including structural & architectural for the said work.
